# Direct Archdiocesan District Office of Education REPORT TO THE 41st BIENNIAL CLERGY LAITY CONGRESS

## **Focus**

The Direct Archdiocesan District Office of Education serves the parochial day and afternoon schools of the District. It provides schools with **a**) curricula and materials for the teaching of Modern Greek, **b**) in-service training to all teachers (Greek and English programs), and **c**) the *Comprehensive Examination in Modern Greek* as an assessment tool of student learning.

In addition, the District Office of Education represents the parochial day schools of New York at the **federal** (*U.S. Department of Education*, Washington, DC), **state** (*State Education Department*, Albany), and **city** (*NYC Department of Education*) education authorities.

The District Office of Education is also represented at the *Standing Committee of NYC Religious Schools Officials* by its director. This Committee consists of representatives from the following religious institutions: the Roman Catholic Archdiocese of New York, the Roman Catholic Diocese of Brooklyn, the Board of Jewish Education, Agudath Israel of America, the Lutheran Schools Association, and the Islamic Schools Association.

# The District Schools

## FEDERAL FUNDS ALLOCATED FOR THE NYC DAY SCHOOLS

The New York City Department of Education (NYC DOE) is responsible for ensuring that services are provided equitably to nonpublic schools throughout NYC under federal funding of Titles I-IV of the Elementary and Secondary Education Act of 1965. Funds for education services to nonpublic schools are proportioned according to the number of students attending these schools, their family's income, and their scores in state tests.

Under Title I, nonpublic schools receive supplemental education services in reading and writing, mathematics, and English as a Second Language (ESL) as well as ancillary student support services to students who demonstrate academic needs and live within the attendance area of a public school eligible for such services. Title IIA funds are allocated for the professional development of nonpublic school teachers to improve teaching and learning in those schools. Title III funds provide resources to children who are limited English proficient to help them attain English proficiency. And Title IV supports programs that involve parents and the community.

The Division of Nonpublic Schools/21<sup>st</sup> Century Partners in Learning of the NYC Department of Education consults regularly with the members of the *Standing Committee of Religious and Independent School Officials*, in order to ensure that federal funds are appropriately distributed to the NYC faith-based schools.

As a member of the *Standing Committee of Religious and Independent School Officials*, the director of the Office of Education of the Direct Archdiocesan District, Maria Makedon, participates in meetings with the NYC Chancellor of Education, **Dennis Walcott** as well as attends conferences held in Albany, the New York State capital, and at the U.S. Department of Education, in Washington, DC.

For the past two school years (2010-2011 and 2011-2012), the *Direct Archdiocesan District Office of Education* was able to secure approximately \$197,000.00 in federal funds as a result of its direct communication with the authorities. The funds were spent – as required – on **teacher training** and for the **purchase of materials and equipment**, such as *textbooks*, *smart boards*, and *overhead projectors*. In addition, low performing students of schools that are located in low income populated areas received laptops as well as storage cabinets for books worth over \$100,000.00.

It is worth noting that **five** teachers who are currently serving in the NYC parochial day schools are doing graduate studies in colleges and universities, their tuition paid by federal funds.

## CONFERENCES AND MEETINGS

# MAJOR PROJECTS & EVENTS

Following are the major projects and events of the Direct Archdiocesan District Office of Education that have taken place since the last **CLC** (**July 4-8, 2010**):

# The Comprehensive Examination in Modern Greek

The *Comprehensive Examination in Modern Greek* is a foreign language test that assesses student proficiency in *listening*, *speaking*, *reading*, and *writing* Modern Greek. Public and nonpublic school students in New York who pass the *Examination* receive foreign language credit in high schools. It developed and administered by the District Office of Education in June of each year.


Despite the substantial changes made lately to the NY State Assessment Program that included the elimination of all comprehensive examinations in languages other than English, the



Direct Archdiocesan District Office of Education continues its efforts to uphold the right of the Archdiocese to develop the *Comprehensive Examination in Modern Greek* benefitting the students of the parochial day and afternoon schools of the District. The Office estimates that more than 20,000 students have taken the *Examination*.

This year's *Comprehensive Examination in Modern Greek* is scheduled to be administered on **Monday**, **June 18, 2012** to **515** students at **12** test sites located in New York, New Jersey, Virginia and North Carolina. All in all, students from **48 Greek American day and afternoon schools** as well as from **4 high schools** and **1 Charter School** in New York will be taking the Examination.

It is worth noting that the number of students who have taken the *Comprehensive Examination in Modern Greek* during the past 10 years has remained almost the same as indicated in the Table below. (*This Table does not include public school students due to lack of information*)



# The Curriculum on Modern Greek Language (at Checkpoint A)

In collaboration with the Institute of Modern Greek Studies of the Aristotle University of Thessaloniki, the Direct Archdiocesan District Office of Education has developed a *Curriculum of Modern Greek Language* (at Checkpoint A).

The *Curriculum* was created in accordance with the standards and objectives of teaching a second/foreign language stated in the **Syllabus** "*Modern Languages for Communication*" of the New York State Education Department. It offers valuable guidance to the Greek teachers who prepare students for the *Comprehensive Examination in Modern Greek*.

# The Annual District Staff Development Seminar



In November of each year, the Direct Archdiocesan District Office of Education organizes a *Staff Development Seminar* offering in-service training to the teachers of the day and the afternoon schools of the *District*.

Held under the auspices of **His Eminence Archbishop Demetrios of America,** the *Seminar* includes an array of workshops pertaining to the English and Greek curricula – covering pre-K to high school grades. More than **300** administrators and teachers attend the *Seminar* each year.

Since the last CLC (July 4-8, 2010), two Staff Development Seminars have taken place:

# 1) November 2, 2010 – St. Demetrios High School, Astoria

Professors of the School of Literacy & TESOL/St. John's University and of Manhattanville College made special presentations on how to enhance the English program of the day schools. The Greek teachers attended the presentations of two distinguished university professors of the *Aristotle University of Thessaloniki*, Greece -- Dr. Georgios Papanastasiou, professor of Linguistics, who spoke on "Loan Words: How to Use Them in Teaching the Greek Language," and Prof. Panagiotis Andreou, who entertained the topic "Student Assessment of Language Skills" that has an important bearing on modifying teaching strategies.

## 2) November 8, 2011 – St. Demetrios High School, Astoria

**His Eminence Archbishop Demetrios of America** was the keynote speaker at this Teachers Seminar. Dr. Christos Tsolakis, professor emeritus of the Paedagogical School / Department of Elementary Education /The Aristotle University of Thessaloniki, addressed the Greek teachers on the topic "Language, Paideia, & Teaching." Dr. Tsolakis is a renowned educator in the field of teaching the Greek language and writer of Greek grammar and other school books.

# The Annual Spelling Bee Competition

The Direct Archdiocesan District Office of Education organizes a *Spelling Bee Competition* among students of the New York City parochial day schools. Local school competitions take place during the months of October-November. The *District's* finals are held at the Archdiocese in December.

Since the last **CLC** (**July 4-8, 2010**), **two** *Spelling Bee Competitions* were organized by the District Office as follows: 1) on Tuesday, **December 14, 2010** and 2) on Tuesday, **January 10, 2012**.



The *District's Spelling Bee Competition* is held under the auspices of **His Eminence Archbishop Demetrios of America**. The Archbishop congratulates and presents each finalist with a "*Certificate of Award*" and the Merriam-Webster's Collegiate Dictionary. At this year's finals, **His Grace Bishop Andonios** of Phasiane, Chancellor of the Archdiocese, sent a congratulatory letter, on behalf of the *District*, to each school bee along with a \$200 check and a \$500 check to the finalist.

For the past four years, Mr. Nick Katsoris, Esq, president of the *Hellenic Times Scholarship Fund* (HTSF) and author the *Loukoumi* Book Series, offers a \$100 award to each school bee and \$500 to the finalist.

The *Spelling Bee Competition* is an educational endeavor sponsored by *The E.W. Scripps Company*, in conjunction with over 260 newspapers around the world. Sponsors organize spelling bee programs in their locales and send their champions to the finals of *The Scripps National Spelling Bee* that takes place in Washington, DC, in the spring of each year.

# The Three Hierarchs Awards Student Event



In conjunction with the Three Hierarchs Feast Day and in celebration of Greek Letters, the Direct Archdiocesan District Office of Education organizes, in January of each year, a special event to honor the students who demonstrate excellence in the Greek language. Honorees are selected on the basis of their score attained on the *Comprehensive Examination in Modern Greek*.

The Three Hierarchs Awards Student Event is held under the auspices of **His Eminence Archbishop Demetrios of America**, who presents the honorees with the *Three Hierarchs Award of Excellence*.

Since the last CLC (July 4-8, 2010), the following events have taken place:

## 1) Saturday, January 29, 2011 – Holy Trinity Cathedral, NYC

Mrs. Maria Perdikogiannis Zolotas, an educator and school board chairperson of the *Greek Afternoon School "Stephanos & Areti Tserpelis"* of St. Nicholas, Flushing, was the keynote speaker. She spoke on *"Studying Greek Language & Culture: A Pathway to Success."* Mrs. Anne Prokop, principal of the *Greek American Institute*, Bronx, was the MC. The program featured a musical performance by the students of *St. Demetrios School*, Astoria, under the direction of Mr. Vagelis Haziroglou.

## 2) Saturday, January 28, 2012 – Holy Trinity Cathedral, NYC

Mrs. Aravella Simotas, a member of the New York State Assembly representing the Queens District, was the keynote speaker. The topic of her speech was "Greek: The Language of Democracy." Mrs. Athena Kromidas, principal of the "W. Spyropoulos" Greek-American Day School of St. Nicholas, Flushing, was the MC. The program featured a musical performance by the students of "W. Spyropoulos" Greek-American School, under the direction of Ms. Areti Giovanou.




